### **General Contest Official Rules**

1. Contests are open to all qualified person, 18 year or older, except employees of KATP-FM/KIXZ-AM/KPRF-FM/KMXJ-FM/KXSS-FM, Townsquare Media (aka "The Company"), all other area broadcasting companies, their affiliates, subsidiaries, agencies and their immediate families. There is no purchase necessary.
2. Prize(s): Prizes are not transferable, redeemable for cash or exchangeable for any other prize. All prizes must be picked up within 30 days of winning. If a winner cannot be contacted or is disqualified, the company reserves the right to determine an alternate winner or not to award that winner's prize, in its sole discretion.
3. Eligibility and Limitations. Participants and winner(s) must be U.S. residents at least 18-years old as determined by the Company and reside in the Station's Total Survey Area (TSA). A parent or guardian or any participant who is a minor must sign a release on behalf of the minor to be eligible to receive a prize, but the Company reserves the right to refuse to award a prize, but the Company reserves the right to refuse to award a prize to or on behalf of any minor. Only one (1) entry per person. Only one (1) prize per household for the Contest. Only one (1) prize per household for the thirty (30) day period. If prize(s) value exceeds \$100 dollars in value, time increases to 90-days. Employees of the Company, the Contest's participating sponsors and their advertising agencies, employees of other radio or television stations, and members of the immediate family of any such person are not eligible to participate and win. The term "immediate family" includes spouses, siblings, parents, children, grandparents, and grandchildren, where as "in-laws," or by current or past marriage(s), remarriage(s), adoption, co-habitation or other family extensions, and any other person residing at the same household whether or not related.
4. Telephone and Delivery Disclaimer. If a contest is to call in to win and/or a telephone is needed to participate in the Contest, participants are restricted to the use of ordinary telephone equipment. Participants that enable the "Caller ID" block function will not be allowed to participate unless they enter their correct area code and telephone number if prompted, or disable the features inhibiting their participation in the Contest. The Company disclaims all liability for the inability of a participant or complete or continue a telephone call due to equipment malfunction, busy lines, inadvertent disconnections, acts beyond the Company's control, or otherwise. For all contests the Company disclaims all liability for any delays, misdelivery, loss, or failure in the delivery of any item sent by mail, courier, express, electronic transmission, or other delivery method. The Company is not responsible for mechanical, technical, electronic, communications, telephone, computer, hardware or software errors, malfunctions or failures of any kind, including: failed, incomplete, garbled, or delayed transmission of online entries, traffic congestion on telephone lines, the internet or at any website or lost or unavailable network

connections which may limit an online entrant's ability to participate in the contest, and any injury or damage to entrant's or any other person's computer related to or resulting from participation in or downloading any information necessary to participate in the contest. Entry forms in a register-to-win contest must be handwritten. No photocopies or mechanical reproduction of entry forms is permitted.

5. **Publicity. Use of Personal Information.** By participating, where allowed by law, all participants and winner(s) grant the Company exclusive permission to use their names, characters, photographs, voices, and likenesses in connection with promotion of this and other contests and waive any claims to royalty, right or remuneration for such use. By participating in the Contest, where allowed by law, participants agree that the Company may disclose personal information obtained from participant in the Contest to third parties and use such information for marketing and other purposes.
6. **Release.** By participating in the Contest, each participant and winner waives any and all claims of liability against the Company, its employees and agents, the Contest's sponsors and their respective employees and agents, for any personal injury or loss which may occur from the conduct of, or participation in, the Contest, or from the use of any prize. In order to receive a prize, participants must sign an official waiver form provided by the Company.
7. **Taxes.** Any valuation of the prize(s) stated above is based on available information provided to the Company, and the value of any prize awarded to a winner may be reported for tax purposes and required by law. Each winner is solely responsible for reporting and paying any and all applicable taxes related to the prize(s) and paying any expenses associated with any prize which are not specifically provided for in the official rules. Each winner must provide the number or social security number before any prize will be awarded. Any person winning over \$600 in prizes from the Company will receive an IRS for 1099 at the end of the calendar year and a copy of such form will be filed with the IRS.
8. **Conduct and Decisions.** By participating in the Contest, participants agree to be bound by the decisions of the Company personnel. Persons who violate any rule, gain unfair advantage in the Contest, or obtain winner status using fraudulent means will be disqualified. Unsportsmanlike, disruptive, annoying, harassing or threatening behavior is prohibited. The Company will interpret these rules and resolve any disputes, conflicting claims or ambiguities concerning the rules of the Contest and the Company's decisions concerning such disputes shall be final. If the conduct or outcome of the Contest is affected by human error, any mechanical malfunctions or failures of any kind, intentional interference or any event beyond the control of the Company, the Company reserves the right to terminate this Contest, or make such other decisions regarding the outcome as the Company deems appropriate. All decisions will be made by the Company and are final. The Company may waive any of these rules in its sole discretion. **ANY ATTEMPT BY A CONTESTANT OR ANY OTHER INDIVIDUAL TO DELIBERATELY CIRCUMVENT, DISRUPT OR DAMAGE ORDINARY AND NORMAL OPERATION OF THIS CONTEST, TELEPHONE SYSTEMS OR WEBSITES, OR**

UNDERMINE THE LEGITIMATE OPERATION OF THE CONTEST IS A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, THE COMPANY RESERVES THE RIGHT TO SEEK DAMAGES FROM ANY SUCH PARTICIPANT TO THE FULLEST EXTENT PERMITTED BY LAW.

9. Miscellaneous. Each Winner must submit proof of eligibility and sign the company's release form to claim the prize. The Company may substitute prizes, amend the rules or discontinue the Contest at any time as announced on the station(s). The Company disclaims any responsibility to notify participants of any aspect related to the conduct of the Contest. All entries become property of the Company and will not be returned.
