I fully realize, understand and acknowledge the dangers of participating in the event which involves a dance contest and that no amount of care, caution or expertise can eliminate such dangers. I EXPRESSLY AND VOLUNTARILY ASSUME RESPONSIBILITY FOR ALL RISK OF PERSONAL INJURY OR DEATH SUSTAINED WHILE PARTICIPATING IN THE EVENT WHETHER OR NOT CAUSED BY THE NEGLIGENCE OF STATION AND/OR ITS EMPLOYEES OR AGENTS.

I hereby acknowledge receipt of the event and hereby accept same as my prize as a winner in the contest on station.

I am responsible for any taxes and fees of any type associated with my receipt and/or use of any prize including, without limitation, income taxes and sales and use taxes, and any expenses associated with any prize, which are not specifically provided for in the official rules. I authorize the Station to withhold from any cash prize any amounts required to be withheld pursuant to federal, state or local law.

I, for myself and my personal representatives, heirs, successors, and assigns, in consideration for being involved in the event, hereby hold harmless, release, defend, indemnify and discharge from liability and waive any claim which I might state against any person or entity involved with the event including but not limited to, the sponsoring organizations, GAP Broadcasting Tri-Cities, LLC, KVEW-TV, Studio 8 Dance, Benton Franklin Fair and their respective subsidiaries, affiliates, officers, directors and employees, volunteers at the event, and individual property owners from all liability, claims, judgments, demands, controversies, agreements, damages, actions, and causes of action whatsoever, either in law or equity, no matter what the cause of my loss, including the negligence of the above named parties, which I have or may have at any time arising out of my association with, travel to or from, or participation in the event or any of its associated activities, or are in any other way related to or resulting from the event or any prizes awarded in connection therewith. I further agree to indemnify and hold

harmless any of the above named parties from any claim arising out of my participation in the event, even if the claim arises out of their negligence. I acknowledge that station and the officers, directors, agents and employees of GAP Broadcasting Tri-Cities, LLC, are not acting as the manufacturer or distributor of the event. Station, acting as a consumer, acquired the event for the purpose of awarding it to a winner in the contest. # Dancing at the Fair: Freestyle Dance Contest - Contest Rules

All participants must fill out an official application packet. Complete the packet and submit to **GapWest Broadcasting; 2621 W. 'A' Street, Pasco, WA by 5pm August, 18th.**

This contest is open to amateur competitors only excluding all employees of GapWest Broadcasting and KVEW-TV. Contestants restricted to 2-16 years of age.

All entrants under the age of 19 years of age must have parental consent and be accompanied by an adult for the performance at the Benton Franklin Fair & Rodeo.

All entrants must perform as a single act or duo. No groups will be allowed. Entrants choosing to perform with props must supply their own equipment.

All entrants are required to perform one (1) routine for the competition. Each routine performed in the contest cannot exceed 1 minute. In the event any song runs longer than 1 minute, the performance will be faded out at 1:05.

The entrant is responsible for providing music to perform with in the form of a CD and must be queued. Contestant must have CD ready at the competition.

In the event your own music fails or skips during your performance, that dance will be scored accordingly and no restart will be given, unless due to faulty equipment.

All entrants are required to be at the contest location no later than ½ hour prior to the competition/performance. The competition will run 4pm – 6pm at the Inland Community Stage (by the food court) at the Benton Franklin Fair & Rodeo, Wednesday, August 25<sup>th</sup>.

Performer's participation is not confirmed until the entry form has been received and confirmed by GapWest Broadcasting. A maximum of five (5) performers will be accepted to perform in each division.

GapWest Broadcasting is responsible for the selection of judges. A minimum of three (3) judges will be provided for each competition, and all judges' decisions are FINAL! Score sheets are the property of GapWest Broadcasting and will not be shared with anyone other than the contest officials.

Each competitor will be scored by each judge individually. The judges will use the following score sheet based on the following criteria. There are four categories with up to 5 points earned in each. A total score of 20 will be considered a perfect score. For questions regarding the judging process and criteria, please feel free to contact us.
